ADEM Permitted Medical Waste Treatment Facilities

Notice Concerning Use of Permitted Medical Waste Treatment Facilities

It is the responsibility of the transporter offering medical waste for treatment to ensure the treatment facility used is currently permitted to treat medical waste. Alabama medical waste treatment permits are valid for and must be renewed every five years. Therefore, transporters offering medical waste for treatment should verify that the treatment facility is properly and currently permitted to accept the medical waste. All treatment facilities should be able to provide a copy of their current and valid permit upon request to anyone offering medical waste for treatment. An approved manifest also must be completed by all parties for every medical waste shipment. See the last page for information on out of state treatment facilities.
