2 Good evening and welcome to the public hearing on behalf of the Alabama Department  
3 of Environmental Management.

4 My name is XXXXXX XXXXX. I am the designated Hearing Officer for these proceedings.  
5 The role of the Hearing Officer is limited to ensuring an orderly hearing so that an accurate  
6 record of this hearing may be developed for the Department's evaluation. I do not make any  
7 decisions regarding these proposed permit actions.

8 On behalf of the Department, we appreciate your participation in tonight's hearing for the  
9 following proposed permit action for Tennessee Valley Authority's Colbert Fossil Plant Ash  
10 Pond 4 located near 900 Colbert Steam Plant Road, Tuscumbia, Alabama 35674:

- 12 • The proposed initial issuance of a Coal Combustion Residuals (CCR) Permit No. 17-  
13 11 to close the Plant Colbert Ash Pond 4.

15 The purpose of this hearing is to provide the public with an opportunity to present oral  
16 testimony on the proposed permit actions.

17 In addition to oral testimony, the Department also will consider all written comments  
18 submitted before the close of the public comment period. The Department has requested your  
19 comments, and we appreciate you taking the time to make them known to us.

20 On June 29, 2022, notice of the date, time, place, and purpose of this hearing was posted  
21 on the Department's website. In addition, the Department sent notice of this hearing by email to  
22 individuals and organizations who had previously requested advance notice of permit

23 proceedings. A copy of the notice and the email distribution list will be entered into the record  
24 of these proceedings.

25 Copies of the public notice permit application, preliminary determination, and draft  
26 permit have been made available for inspection by the public at the offices of the Department at  
27 1400 Coliseum Boulevard in Montgomery, as well as on the Department's website.

28 This hearing is open to the public and anyone wishing to present oral testimony or submit  
29 a written statement may do so. Lengthy statements or those containing considerable technical or  
30 other complex data should be submitted in writing. Summaries of such statements may be  
31 presented orally.

32 All testimony and written comments should be as factual as possible and should address  
33 the subject of this hearing.

34 This hearing is an opportunity for members of the public to offer comments to help  
35 ensure that all relevant factors are considered before a final permit decision is made.

36 Please be advised that the Department is limited in the factors it can consider when  
37 making permit decisions and must base the determinations only on whether the permit applicant  
38 has satisfied those requirements of applicable environmental statutes and regulations granted to  
39 ADEM by the Legislature.

40 Persons giving testimony may be questioned by the Hearing Officer or other Department  
41 staff to clarify points and to develop a better understanding of what is being presented.

42 This proceeding tonight is not an open forum as in a question-and-answer session. This  
43 hearing is an opportunity for you to submit comments that you wish the Department to consider  
44 in the final review of the permit applications. However, you may pose a comment in the form of

45 a question which will be compiled and addressed by the Department in its complete response to  
46 comments.

47 In addition to oral testimony, written comments may be submitted on the proposed permit  
48 actions. You do not have to make an oral statement tonight in order to have your written  
49 comments considered by the Department.

50 Written statements may be submitted to the Hearing Officer tonight or delivered to the  
51 Department in Montgomery, as directed in the public notice for this hearing. All written  
52 statements previously submitted and those received by the Department before the end of the  
53 public comment period will be included in the hearing record.

54 It is important to note that written comments submitted through postal or electronic mail  
55 are given the same consideration as those that are presented in person at this hearing. All oral  
56 and written testimony will be included in the hearing record.

57 After giving full consideration to the hearing record, the Department will make its final  
58 decision on the proposed permit actions and develop responses to comments for the proposed  
59 permits. The hearing record, final permit determinations, and responses to comments will be  
60 posted to the Department's eFile System.

61 This hearing is being captured by a court reporter to develop a transcript of this hearing  
62 for review by the Department. In addition, the entire proceeding is being recorded on video to be  
63 posted on the Department's YouTube channel to make it accessible to the public.

64 Now let us move on to the purpose of this hearing, the receipt of public comments. The  
65 order of appearance of persons giving testimony will be as follows: first, representatives of the  
66 Department's Land Division; then, a representative of the Tennessee Valley Authority; then, any  
67 elected officials or their representatives who have preregistered to speak. All remaining

68 members of the public will be heard in the order in which they registered during the  
69 preregistration offered online or by phone and then those that registered on-site at this hearing.

70 I now recognize Mr/Ms.Xxxxxx Xxxxxx to present a statement on behalf of the  
71 Department's Land Division.

72 **[After Mr./Ms. XXXXXXXX speaks:]**

73 **[If permit applicant representative preregistered to speak]** We will now proceed to  
74 the receipt of public comments from a representative of the permit applicant. First, I recognize  
75 [Title and Full Name of Official].

76 **[After permit applicant representative enters]** Please step up to the microphone and  
77 clearly restate your name and title that you hold. Please speak clearly into the microphone to  
78 ensure an accurate record of your testimony can be recorded.

79 **[After permit applicant representative speaks:]**

80 **[If elected officials have preregistered to speak]** We will now proceed to the receipt of  
81 public comments from elected officials. First, I recognize [Title and Full Name of Official].

82 **[After elected official enters]** Please step up to the microphone and clearly restate your  
83 name and the office that you hold. Please speak clearly into the microphone to ensure an  
84 accurate record of your testimony can be recorded.

85 **[After all elected officials have spoken:]**

86 We will now proceed to the receipt of comments from members of the public. As  
87 indicated in the public notice for this hearing, oral testimony for each registered speaker is  
88 limited to seven minutes. If anyone has prepared a statement that cannot be presented in a 7-  
89 minute time frame, please use your time for oral testimony to summarize your comments and  
90 submit your full statement to the Department in writing for placement in the record.

91 First, I recognize [Name of Registered Speaker].

92 **[After registered speaker enters]** Please step up to the microphone and clearly restate  
93 your name and the name of any interest or organization that you represent. Please speak clearly  
94 into the microphone to ensure an accurate record of your testimony can be recorded. Please also  
95 remember that this is not a question and answer session.

96 **[After all registered speakers have spoken:]**

97 Since there are no further registered speakers, please be advised that unless otherwise  
98 notified, the public comment period will end at 5:00 p.m. on Thursday, August 11, 2022. All  
99 comments must be received at the offices of the Department in Montgomery by that time.

100 After consideration of all oral and written comments, the Department will make its  
101 determinations regarding the proposed permit action and prepare responses to all relevant  
102 comments received.
