### Introduction

Activities that take place at industrial facilities, such as material handling and storage, are often exposed to the weather. As runoff from rain comes into contact with these activities, it can pick up pollutants and transport them to a nearby storm sewer system or directly to a river, lake, or coastal water. To minimize the impact of stormwater discharges from industrial facilities, the Alabama NPDES program includes an industrial stormwater permitting component. The Department developed general permits covering 19 categories of industrial activity that require authorization under an NPDES industrial general permit for stormwater, or non-stormwater in the case of discharges such as noncontact cooling water or hydrostatic testing. General Permits primarily address industrial storm water discharges.

General permits are "one-size-fits-all" types of permits that significantly restrict the manner in which a specific type of regulated activity may be carried out. The term, "general," is commonly used in the National Pollutant Discharge Elimination System (NPDES) Program. General permits are best suited for the regulation of numerous, very similar, and generally smaller facilities and sources that have low levels of emissions and discharges. General Permits are written for a type of industry, such as the salvage industry or the transportation industry. Under the Federal regulations, facilities with certain Standard Industrial Classification (SIC) Codes must have their stormwater covered under an NPDES Permit or they must achieve, maintain, and certify to "no industrial exposure."

The possible environmental impacts associated with one salvage yard can reasonably be expected to be about the same as the environmental impact associated with all other salvage yards of similar size. So long as the applicant agrees to conduct its proposed activities under the pre-set limits established by the effective general permit, it will be able to operate under any general permit for which it is eligible. In this example of salvage yards, the facility is issued a permit which is renewable every five years. (The rules governing these permits are found in chapter 335-6-6-.23 of the ADEM Code.)

Thus, general permits have been created for these "cookie-cutter" types of activities. Because there are so many sources or facilities involved statewide in the types of activities allowable under a general permit, ADEM is able to save a great deal of staff time and state resources by using them. Instead of considering individual or "custom" permit requests for common and widespread activities, ADEM's general permits ensure that the environment is protected from the effect of salvage yards or other "like" activities.

Facilities and sources whose discharges could have a significant environmental impact are not covered under a general permit. Individual permits are written specifically for such facilities. Furthermore, facilities or sources operating under a general permit, for which the Department determines that stricter permit conditions are needed in order to meet state water quality standards, will be required to operate under an individual permit. (In addition, any wastewater discharge into a receiving stream classified as an outstanding state resource or exceptional use water is not eligible to obtain or operate under a general permit.)

The nineteen source categories of industrial general permits established by the Department are found in the table on page 2.

In order to be in compliance with ADEM Admin. Code r. 335-6-6-.23(15), you must apply for an initial permit 30 days prior to discharge and a permit renewal at least 90 days in advance of permit expiration.

## General NPDES Permit Guidance

### New Application/Renewal Process:

Determine which category applies to your particular business and note the Notice of Intent (NOI) application form number (see table on opposite page or the forms table found on page 5).

1. Facilities are encouraged to submit the application and application fee through ADEM's eNOI system at <http://www.adem.alabama.gov/eNOI>. The eNOI system accepts payment by VISA or MasterCard.
2. If the eNOI system is not utilized, the application is available online for download at <http://www.adem.alabama.gov/DeptForms/default.cnt>.
  - a. Complete the General Permit Notice of Intent (NOI) in its entirety.
  - b. The responsible official must sign the NOI.
  - c. Enclose a check for \$1,155.00 (permit fee) made payable to ADEM (Alabama Department of Environmental Management). Please reference your permit number on the check.
  - d. Mail the application and check as follows:
