FINDINGS

Pursuant to the provisions of the Alabama Environmental Management Act, Ala. Code §§ 22-22A-1 to 22-22A-17, as amended, the Alabama Air Pollution Control Act, Ala. Code §§ 22-28-1 to 22-28-23, as amended, the Alabama Department of Environmental Management ("Department" or "ADEM") Administrative Code of Regulations ("ADEM Admin. Code r.") promulgated pursuant thereto, and the federal Clean Air Act, 42 U.S.C. 7401 to 7671q, as amended, the Department makes the following FINDINGS:

- 1. The City of Glencoe (Glencoe) owns real property located at latitude/ longitude (33.95252, -85.92870) on 206 Pineview Avenue, Glencoe, Etowah County, Alabama ("Site), and is responsible for the demolition of the structure located at the Site.
- 2. The Department is a duly constituted department of the State of Alabama pursuant to Ala. Code §§ 22-22A-1 to 22-22A-17, as amended.
- 3. Pursuant to Ala. Code § 22-22A-4(n), as amended, the Department is the state air pollution control agency for the purposes of the federal Clean Air Act, 42 U.S.C. 7401 to 7671q, as amended. In addition, the Department is authorized to administer and

enforce the provisions of the Alabama Air Pollution Control Act, <u>Ala. Code</u> §§ 22-28-1 to 22-28-23, *as amended*.

- 4. The U.S. Environmental Protection Agency's National Emission Standard for Hazardous Air Pollutants (NESHAP), found at 40 C.F.R. Part 61, Subpart M, is incorporated by reference in ADEM Admin. Code r. 335-3-11-.02(12).
- 5. 40 C.F.R. § 61.145(a)(1) states that in a facility being demolished, all the requirements of paragraphs (b) and (c) of this section apply, except as provided in paragraph (a)(3) of this section, if the combined amount of RACM is at least 260 linear feet on pipes, at least 160 square feet on other facility components, or at least 35 cubic feet off facility components where the length or area could not be measured previously.
- 6. 40 C.F.R. § 61.145(b)(3)(i) requires the owner or operator of a demolition or renovation activity for a subject facility to provide written Notice of Intention to Demolish or Renovate ("Notice") at least ten workdays before demolition, asbestos stripping or removal work, or any other activity which disturbs the asbestos.
- 7. ADEM Admin. Code r. 335-3-3-.01(2)(b)4 states that "Only vegetation and untreated wood may be burned. It is unauthorized to open burn heavy oils, asphalt products, plastics, vinyl materials, insulation, paper, cardboard, natural or synthetic rubber, salvage or scrap materials, chemicals, garbage, treated or painted wood, or any trash."
- 8. On April 26, 2024, Department personnel received a complaint that commercial structures had been demolished and burned at the Site, in violation of ADEM. Admin. Code r. 335-3-11-.02(12).
 - 9. On May 7, 2024, the Department issued a Noice of Violation to Glencoe.
- 10. On June 13, 2024, the Department received a response from Glencoe. The response confirmed there was no asbestos inspection completed prior to demolition,

materials were burned to keep costs low for Glencoe, and that Glencoe completed the demolition by burn from April 18, 2024 through April 26, 2024.

- 11. Pursuant to Ala. Code § 22-22A-5(18)c., as amended, in determining the amount of any penalty, the Department must give consideration to the seriousness of the violation, including any irreparable harm to the environment and any threat to the health or safety of the public; the standard of care manifested by such person; the economic benefit which delayed compliance may confer upon such person; the nature, extent and degree of success of such person's efforts to minimize or mitigate the effects of such violation upon the environment; such person's history of previous violations; and the ability of such person to pay such penalty. Any civil penalty assessed pursuant to this authority shall not exceed \$25,000.00 for each violation, provided however, that the total penalty assessed in an order issued by the Department shall not exceed \$250,000.00. Each day such violation continues shall constitute a separate violation. In arriving at this civil penalty, the Department has considered the following:
- A. SERIOUSNESS OF THE VIOLATION: Glencoe failed to have an asbestos inspection performed and to submit the required notification to the Department prior to demolishing the building. Also, Glencoe conducted unauthorized open burning at the Site. The Department considers these violations to be serious.
- B. THE STANDARD OF CARE: There appeared to be no care taken by Glencoe prior to demolition by complying with the applicable requirements of the ADEM Admin. Code r.
- C. ECONOMIC BENEFIT WHICH DELAYED COMPLIANCE MAY HAVE CONFERRED: Glencoe derived economic benefit by not having the required asbestos inspection performed and not legally disposing of regulated materials.

- D. EFFORTS TO MINIMIZE OR MITIGATE THE EFFECTS OF THE VIOLATION UPON THE ENVIRONMENT: There were no efforts by Glencoe to mitigate possible effects of these violations upon the environment.
- E. HISTORY OF PREVIOUS VIOLATIONS: Glencoe has no known history with the Department for violating demolition/asbestos regulations.
- F. THE ABILITY TO PAY: Glencoe has not alleged an inability to pay the civil penalty.
- G. OTHER FACTORS: The Department has carefully considered the six statutory penalty factors enumerated in <u>Ala. Code</u> § 22-22A-5(18)c., *as amended*, as well as the need for timely and effective enforcement, and has concluded that a civil penalty herein is appropriate (*See* "Attachment A", which is hereby incorporated into these Findings).

<u>ORDER</u>

Based upon the foregoing FINDINGS and pursuant to Ala. Code §§22-22A-5(10), 22-22A-5(12), 22-22-5(18), and 22-28-18, as amended, it is hereby ORDERED:

A. That, not later than forty-five days after the issuance of this Order, Glencoe shall pay to the Department a civil penalty in the amount of \$4,000.00 for the violations cited herein. Said penalty shall be made payable to the Alabama Department of Environmental Management by certified or cashier's check and shall be submitted to:

B. That, immediately upon receipt of this Order and continuing thereafter, Glencoe shall ensure immediate and future compliance with 40 C.F.R. Part 61, Subpart M.

as adopted in ADEM Admin. Code r. 335-3-11-.02, particularly as it applies to renovation and demolition operations.

- C. That, should any provision of this Order be declared by a court of competent jurisdiction or the Environmental Management Commission to be inconsistent with Federal or state law and therefore unenforceable, the remaining provisions hereof shall remain in full force and effect.
- D. Except as otherwise set forth herein, this Order is not and shall not be interpreted to be a permit or modification of an existing permit under federal, State or local law, and shall not be construed to waive or relieve Glencoe of their obligations to comply in the future with any permit or other written direction from the Department.
- E. That, issuance of this Administrative Order does not preclude the Department from seeking criminal fines or other appropriate sanctions or relief against Contractor for the violations cited herein.
- F. That, failure to comply with the provisions of this Administrative Order shall constitute cause for commencement of legal action by the Department against Glencoe for recovery of additional civil penalties, criminal fines, or other appropriate sanctions or relief.
