FINDINGS

Pursuant to the provisions of the Alabama Environmental Management Act, <u>Ala. Code</u> §§ 22-22A-1 to 22-22A-17, as amended; the Solid Wastes and Recyclable Materials Management Act (SWRMMA), <u>Ala. Code</u> §§ 22-27-1 to 22-27-18, as amended; and the Alabama Department of Environmental Management's ("ADEM" or "Department") Administrative Code of Regulations ("ADEM Admin. Code r.") promulgated pursuant thereto, the Department makes the following FINDINGS:

- 1. Christopher S. Sanders ("Mr. Sanders") is the owner and operator of Yellow Dumpster LLC ("Yellow Dumpster"), a waste disposal service, located at 3409 Greenpine Circle in Montgomery, Montgomery County, Alabama.
- 2. Tiffani Q. Sanders ("Ms. Sanders") owns real property, identified as Parcel ID Numbers 11-05-21-4-004-001.007, 11-05-21-4-004-001.008, 11-05-21-4-004-001.009, 11-05-22-3-007-002.001, 11-05-22-3-007-002.002, and 11-05-22-3-007-002.003, located at and near 3409 Greenpine Circle, in Montgomery, Montgomery County, Alabama ("the Site").
- 3. Pursuant to <u>Ala. Code</u> §§ 22-22A-1 to 22-22A-17, as amended, the Department is a duly constituted department of the State of Alabama.
- 4. Pursuant to <u>Ala. Code</u> § 22-22A-4(n), as amended, and <u>Ala. Code</u> § 22-27-9(a), as amended, the Department is the state agency authorized to administer and enforce the provisions of the SWRMMA, <u>Ala. Code</u> §§ 22-27-1 to 22-27-18, as amended.
- 5. Pursuant to <u>Ala. Code</u> § 22-27-10(b), as amended, and ADEM Admin. Code r. 335-13-11-.03(2), any person who participates in the creation or operation of an

unauthorized dump, or contributed to an unauthorized dump, shall be responsible for the removal of the waste or otherwise the closure of the unauthorized dump in accordance with this article and rules of the department. If those who created, operated, or contributed to an unauthorized dump do not remove or close the unauthorized dump, the landowner shall also be responsible for the removal or otherwise the closure of the unauthorized dump.

- 6. Pursuant to ADEM Admin. Code rs. 335-13-1-.13(1)(a) and (2), unauthorized dumps are prohibited and must be closed in a manner determined to be necessary by the Department.
- 7. On December 16, 2022, in response to a complaint, the Department inspected the Site and noted the following:
 - A. The presence of an unpermitted solid waste disposal area.
- B. Yellow Dumpster was operating as a business on the Site at the time of the inspection.
- C. According to Montgomery County property tax records, Ms. Sanders was verified to be the Site's owner at the time of the inspection.
- D. Approximately four hundred cubic yards of regulated solid waste materials, including construction/demolition waste, household waste, and scrap tire material, had been openly dumped on the Site without having a Department-issued solid waste disposal facility permit.
- E. Yellow Dumpster is responsible for the placement of the aforementioned regulated solid waste on the Site, which appears to have resulted in the creation of an unauthorized dump ("UAD").
- 8. On February 8, 2023, the Department conducted a follow up inspection and found that the UAD was still present. Department personnel noted that the estimated volume of regulated waste volume remained the same but approximately one hundred fifty cubic yards of regulated solid waste materials had been placed in roll-off dumpsters.

- 9. Pursuant to <u>Ala. Code</u> § 22-22A-5(18)c., as amended, in determining the amount of any penalty, the Department must give consideration to the seriousness of the violation, including any irreparable harm to the environment and any threat to the health or safety of the public; the standard of care manifested by such person; the economic benefit which delayed compliance may confer upon such person; the nature, extent, and degree of success of such person's efforts to minimize or mitigate the effects of such violation upon the environment; such person's history of previous violations; and the ability of such person to pay such penalty. Any civil penalty assessed pursuant to this authority shall not exceed \$25,000 for each violation, provided however, that the total penalty assessed in an order issued by the Department shall not exceed \$250,000. Each day such a violation continues shall constitute a separate violation. In arriving at this civil penalty, the Department has considered the following:
- A. SERIOUSNESS OF THE VIOLATION: The creation, contribution to, or operation of a UAD is inherently a public nuisance, a threat to public health, and a threat to the environment. The Department is not aware of any irreparable harm to the environment, or any immediate threat to human health or the safety of the public as a result of the UAD's presence on the Site.
- B. THE STANDARD OF CARE: Yellow Dumpster failed to abide by requirements applicable to the lawful disposal of solid wastes and failed to comply with directives from the Department regarding the proper abatement and closure of the UAD.
- C. ECONOMIC BENEFIT WHICH DELAYED COMPLIANCE MAY HAVE CONFERRED: The Department has been unable to establish if Yellow Dumpster has realized a significant economic benefit as a result of the violation cited herein.
- D. EFFORTS TO MINIMIZE OR MITIGATE THE EFFECTS OF THE VIOLATION UPON THE ENVIRONMENT: The Department is unaware of efforts by Yellow Dumpster to mitigate any potential adverse effects upon the environment, human health, or public safety which may have been caused as a result of the UAD.

- E. HISTORY OF PREVIOUS VIOLATIONS: Based on a review of departmental records, Yellow Dumpster has a documented history of noncompliance regarding the disposal of regulated solid waste as prescribed under ADEM Admin. Code div. 335-13. According to departmental records, a similar violation, as cited herein, was documented within the past twelve months. The Department has enhanced the proposed civil penalty to reflect Yellow Dumpster's history of previous violations.
- F. THE ABILITY TO PAY: The Department does not have any evidence indicating Yellow Dumpster's inability to pay the civil penalty assessed herein.
- 10. The Department has carefully considered the six statutory penalty factors enumerated in Ala. Code § 22-22A-5(18)c, as amended, as well as other factors, and has concluded that a civil penalty is appropriate for the violation cited herein (see Attachment A, which is made a part of the Department's FINDINGS).

ORDER

Based on the foregoing FINDINGS and pursuant to <u>Ala. Code</u>, §§ 22-22A-5(1), 22-22A-5(10), 22-22A-5(18), 22-27-4(b), 22-27-7, and 22-27-11, as amended, it is hereby ORDERED:

A. That, not later than forty-five days of issuance of this Order, Yellow Dumpster shall pay to the Department a civil penalty in the amount of \$15,500 for the violation cited herein. The penalty shall be made payable to the Alabama Department of Environmental Management by certified or cashier's check or any other method of payment acceptable to the Department and shall be remitted to:

All payments shall reference Yellow Dumpster's name and address and the ADEM Administrative Order number of this action.

- B. That, immediately upon issuance of this Order and continuing each and every day thereafter, Yellow Dumpster shall cease and desist from creating, operating, or contributing to any UADs.
- C. That, within thirty days of issuance of this Order, Yellow Dumpster shall submit a site closure plan to the Department in accordance with ADEM Admin. Code r. 335-13-1-.13(2)(b)1. This plan shall include a schedule for site closure completion. Unless otherwise directed by the Department, Yellow Dumpster shall implement the site closure plan as presented, remove and properly dispose of or recycle all solid waste materials in a permitted landfill unit or at a legitimate recycling facility, and comply with all applicable requirements of Division 335-13 of the ADEM Admin. Code.
- D. That, within fifteen days of completion of remediation activities, Yellow Dumpster shall provide the following information to the Department as proof that all closure actions have been completed:
 - 1. Time period in which the remediation activities took place.
 - 2. Total volume of waste removed from the Site.
- 3. Documentation that all regulated solid waste, including both surface and subsurface waste, was removed from the Site.
- 4. A copy of receipts documenting that all regulated waste was taken to a permitted MSW landfill or legitimate recycling facility.
- 5. Photographs of the solid waste disposal area(s) on the Site, before and after remediation.
- 6. Documentation that the UAD was properly closed to prevent erosion on the Site, if applicable.
- 7. Documentation that the Site has been secured to prevent any future illegal dumping, if applicable.
- E. That, should any provision of this Order be declared by a court of competent jurisdiction or the Environmental Management Commission to be inconsistent

with Federal or State law and, therefore, unenforceable, the remaining provisions hereof shall remain in full force and effect.

- F. That the issuance of this Order does not preclude the Department from seeking criminal fines or other appropriate sanctions or relief against Yellow Dumpster for the violation cited herein.
- G. That failure to comply with the provisions of the Order shall constitute cause for commencement of legal action by the Department against Yellow Dumpster for recovery of additional civil penalties, criminal fines, or other appropriate sanctions or relief.
