## VISIBLE EMISSIONS CERTIFICATION PROGRAM SPRING 2023

The ADEM Visible Emissions (VE) Certification Program will conduct a certification session during April of 2023. The on-line lecture session will begin March 20-31, 2023. The field certification portion of the program will begin April 11-12, 2023 and will continue, if needed, through April 13, 2023 as a contingency day for weather delays only. See the attached memo from Ronald W. Gore, Chief – Air Division, concerning those who should attend.

The lecture session is required for those certifying for the first time and once every three (3) years thereafter. Field Certification is valid for six (6) months.

There are three (3) methods available for registering to attend the VE Certification Program. Participants can register using the on-line registration procedure, by mail, or on site (additional fee required). The deadline for early registration, either on-line or mail-in is March 31, 2023.

To avoid late fees, mail-in applications must be postmarked by the close of business on March 31, 2023. Participants registering either by mail or on-line after the deadline will be subject to a \$100.00 late fee. Participants that elect to register on site will incur an additional fee of \$50.00. Payment for mail-in and on-site registration can be in the form of check, money order, or credit card. On-line registration will start January 16, 2023, and be available until April 7, 2023 (late fees will apply after March 31, 2023).

Registration may be accomplished by completing the attached registration form and submitting it, along with a method of payment, to ADEM – Air Division by the deadline. Registration forms will not be processed without full payment.

Attendees may register using the **on-line registration procedure**.
