## ADEM Permitted Medical Waste Transporters

### Notice Concerning Use of Permitted Medical Waste Transporters for Medical Waste Shipments

It is the responsibility of the person or facility offering medical waste for transportation (originating the shipment) to ensure the transporter used is currently permitted to transport medical waste. Alabama medical waste transporter permits are valid for and must be renewed every three years. Therefore, persons or facilities offering medical waste for transportation should verify that the transporter is properly and currently permitted to accept the shipment. All transporters should be able to provide a copy of their current and valid permit upon request to anyone offering medical waste for transportation. An approved manifest also must be completed by all parties for every medical waste shipment.
