

Current "needs-based" (physical plant need & financial need) funding program as of 12/31/22:

1. \$3 Billion of proposed projects (\$.5 Billion <u>funded</u> & \$2.5 Billion <u>unfunded</u>)

\$450 million Tier 1 – greatest unfunded need
 \$750 million Tier 2 – second greatest unfunded need
 \$1,300 million Tier 3 – third greatest unfunded need
