

Hazardous Waste Management

2025 Biennial Report

Information presented in this fact sheet is intended to provide a general understanding of the regulatory requirements governing the management of hazardous waste. This information is not intended to replace, limit, or expand upon the complete regulatory requirements found in Division 14 of the Alabama Department of Environmental Management Administrative Code.

BACKGROUND

In accordance with ADEM Administrative Code Rules 335-14-3-.04(2), 335-14-5-.05(6), and 335-14-6-.05(6), Large Quantity Generators (LQG) who ship any hazardous waste off-site to a treatment, storage or disposal (TSD) facility within the United States and Treatment, Storage, and/or Disposal Facilities that receive hazardous waste from off-site facilities or generators must prepare and submit a Biennial Report (BR) to the Department by March 1, 2026. Please retain a copy of your submission on-site.

ELECTRONIC SUBMISSION

ADEM strongly encourages electronic submission of the Biennial Report. Facilities can now enter data via electronic submissions by using the RCRAInfo Industry Application. Instructions for registering for the application are included below. Information from previous Biennial Report years can be pulled into the current report for review and information can be added, corrected, or deleted as needed. REGISTERING FOR THE EPA INDUSTRY USER APP

The EPA Biennial Report can now be submitted electronically through the EPA RCRAInfo Industry User interface. To submit, facilities will need to go to the EPA Industry User app and register.

Then, click on **Register** to begin.

INDUSTRY USER

Select Industry User Registration if you want to submit the RCRA Notification of Waste Activity (myRCRAid), Biennial Report and/or manifest data on behalf of a regulated hazardous waste site, including federal facilities.

The system will then prompt the user for the required information.

Please be aware that your facility must designate a primary preparer.
The primary preparer will be able to designate secondary preparers.

Once the information for registration has been completed, an email will be sent to the authorized site manager for account review and approval. The certifier will then be in contact with the designated preparer to ensure all information is correct.

Please keep track of all usernames and passwords associated with this registration and store them securely. RCRAInfo does allow you to retrieve your User ID and reset your password as necessary on the login page.

Alabama requires the submission of the **OI Form**.

Alabama does not have any State waste codes or waste types.

ADEM cannot accept information submitted electronically through other websites.

NOTE: No fee is required for submitting the Biennial Report.

HELPFUL TIPS

- EPA has added validation checks to the BR application. Please review and respond appropriately to each validation issue. Each comment must be verified and accepted by the Department before the BR submission can be finalized.
- The BR submission does not take the place of the required annual notification. Facilities should submit both the Biennial Report and ADEM Form 8700-12 this year.
- If a BR submission is prepared electronically for a different user to certify, please be sure it is signed and submitted. If a submission is left in draft or awaiting signature, the Department is unable to access the submission. Please be sure the draft is completed.

REMINDER

If your facility operated as a TSD or LQG at any time in 2025, submission of the Biennial Report is required by **March 1, 2025**.
