Consent Order No. 26-XXX-CHW

PREAMBLE

This Consent Order is made and entered into by the Alabama Department of Environmental Management ("the Department" or "ADEM") and TriHaz Solutions, LLC ("TriHaz") pursuant to the provisions of the Alabama Environmental Management Act, Ala. Code §§ 22-22A-1 to 22-22A-17, as amended, and the Alabama Hazardous Wastes Management and Minimization Act ("the AHWMMMA"), Ala. Code §§ 22-30-1 to 22-30-24, as amended, and the regulations promulgated pursuant thereto.

STIPULATIONS

1. TriHaz operates a waste transportation company with EPA Identification Number ALR000013748, located at 3445 Stanwood Boulevard in Huntsville, Madison County, Alabama. TriHaz, as a result of its operations, was a hazardous waste transporter, as defined in ADEM Admin. Code Div. 14, at all times relevant to this action.
2. The Department is a duly constituted department of the State of Alabama pursuant to Ala. Code §§ 22-22A-1 to 22-22A-17, as amended.
3. Pursuant to Ala. Code § 22-22A-4(n), the Department is the state agency responsible for the promulgation and enforcement of solid and hazardous waste regulations in accordance with the federal Solid Waste Disposal Act §§ 1002 to 11012, 42 U.S.C. §§ 6901 to 6992k, as amended. In addition, the Department is authorized to administer and enforce the provisions of the AHWMMMA, Ala. Code §§ 22-30-1 to 22-30-24, as amended.

DEPARTMENT'S CONTENTIONS

4. On August 18, 2022, the Department issued Hazardous Waste Transport Permit Number ALR000013748 ("the permit") to TriHaz. The permit expired on August 21, 2025.

5. On September 2, 2025, the Department received TriHaz's application to renew the permit.

6. On September 14, 2025, TriHaz notified the Department that it had transported hazardous waste in the State of Alabama after the expiration date of the permit. A subsequent review of TriHaz's compliance showed the following:

(a) Pursuant to ADEM Admin. Code r. 335-14-4-.01(2)(c), a non-rail transporter must not transport hazardous waste without having received an Alabama Hazardous Waste Transport Permit in compliance with rules 335-14-8-.09 through 335-14-8-.13.

TriHaz transported six (6) drums of hazardous waste in the State of Alabama on three separate occasions without an effective Hazardous Waste Transport Permit.

(b) Pursuant to ADEM Admin. Code r. 335-14-4-.01(4)(a), a transporter whose base of operations is located within the State of Alabama must submit a correct and complete ADEM Form 8700-12 (including all appropriate attachment pages and fees) reflecting current waste activities to the Department annually.

TriHaz failed to submit ADEM Form 8700-12 to the Department annually for the years 2023 and 2024.

7. On September 26, 2025, the Department issued a Notice of Violation ("NOV") to TriHaz citing the above violations of the hazardous waste regulations.

8. On October 3, 2025, the Department reissued Hazardous Waste Transport Permit Number ALR000013748 to TriHaz.

9. On October 28, 2025, TriHaz submitted to the Department a written response to the NOV, which described the actions TriHaz has taken to prevent recurrence of the violation(s) cited in the NOV.

10. Pursuant to Ala. Code § 22-22A-5(18), as amended, in determining the amount of any penalty, the Department must give consideration to the seriousness of the violation(s), including any irreparable harm to the environment and any threat to the health or safety of the public; the standard of care manifested by such person; the economic benefit which delayed compliance may confer upon such person; the nature, extent, and degree of success of such person's efforts to minimize or mitigate the effects of such violation(s) upon the environment; such person's history of previous violations; and the ability of such person to pay such penalty. Any civil penalty assessed pursuant to this authority shall not exceed \$25,000.00 for each violation, provided however, that the total penalty assessed in an order issued by the department shall not exceed \$250,000.00. Each day such a violation continues shall constitute a separate violation. In arriving at this civil penalty, the Department has considered the following:

(a) **SERIOUSNESS OF THE VIOLATION(S):** In determining the seriousness of the violation(s), the Department considered the general nature and magnitude of the violation(s) along with the available evidence of irreparable harm to the environment and threat to the health or safety of the public. However, the Department is not aware of any irreparable harm to the environment or any threat to the health or safety of the public.

(b) **STANDARD OF CARE:** In considering the standard of care manifested by TriHaz, the Department noted that the violation(s) were administrative and non-technical. Consequently, TriHaz failed to exhibit a standard of care commensurate with the applicable regulatory standards.

(c) **ECONOMIC BENEFIT WHICH DELAYED COMPLIANCE MAY HAVE CONFERRED:** The Department has determined that no significant economic benefit was gained by TriHaz as a result of the violation(s).

(d) **EFFORTS TO MINIMIZE OR MITIGATE THE EFFECTS OF THE VIOLATION(S) UPON THE ENVIRONMENT:** There are no known environmental effects to mitigate as a result of the violation(s).

(e) **HISTORY OF PREVIOUS VIOLATIONS:** Based on a review of Department records, Tri-Haz does not have a history of similar violations.

(f) ABILITY TO PAY: The Department does not have any evidence indicating that TriHaz is unable to pay the civil penalty.

(g) OTHER FACTORS: It should be noted that this Consent Order is a negotiated settlement and, therefore, the Department has compromised the amount of the penalty that is warranted in the spirit of cooperation and the desire to resolve this matter amicably without incurring the unwarranted expense of litigation (see Attachment A, which is made a part of the Department's Contentions).

11. The Department neither admits nor denies TriHaz's Contentions, which are set forth below. The Department has agreed to the terms of this Consent Order in an effort to resolve the alleged violation(s) cited herein without the unwarranted expenditure of State resources in further prosecuting the alleged violation(s). The Department has determined that the terms contemplated in this Consent Order are in the best interest of the citizens of Alabama.

TRIHAZ'S CONTENTIONS

12. TriHaz neither admits nor denies the Department's Contentions. TriHaz consents to abide by the terms of this Consent Order and to pay the civil penalty assessed herein.

13. The violations alleged herein were the result of inadvertent administrative oversight.

14. On August 22, 2025, TriHaz transported two (2) drums of hazardous waste.

15. On August 28, 2025, TriHaz transported one (1) drum of hazardous waste.

16. On August 29, 2025, TriHaz received notice from the Department regarding the lapse of the permit.

17. On September 2, 2025, TriHaz promptly submitted a permit renewal application.

18. On September 5, 2025, based upon the belief that the permit renewal application was sufficient to secure the renewal of the permit, TriHaz transported three (3) additional drums of hazardous waste.

19. After receiving an inquiry from the Department regarding hazardous waste transportation, TriHaz terminated all transportation activities pending receipt of a renewed permit and responded to the Department's inquiry on September 14, 2025.

20. On October 28, 2025, TriHaz provided a written response to the Department's NOV, addressing each such alleged violation and describing the corrective actions implemented to ensure the timely submittal of all permits, required forms, and licenses. Such corrective actions include (i) transferring responsibility for regulatory oversight from TriHaz's operations group to its business oversight group, (ii) implementing a company wide calendaring system providing multiple advance alerts for all permit and form deadlines, (iii) establishing a twice-monthly automated workflow process listing all pending regulatory obligations, (iv) adding regulatory permit status as a standing agenda item for weekly management meetings, and (v) including ADEM Form 8700-12 in its overall regulatory review process.

21. Following the submission of the written response, TriHaz submitted ADEM Form 8700-12 for years 2023 and 2024.

ORDER

Therefore, without admitting that it has violated any statutes or regulations, TriHaz, along with the Department, desires to resolve and settle the alleged violation(s). The Department has carefully considered the facts available to it and has considered the six penalty factors enumerated in Ala. Code § 22-22A-5(18)c., as amended, as well as the need for timely and effective enforcement. The Department believes that the following conditions are appropriate to address the alleged violation(s). Therefore, the Department and TriHaz agree to enter into this Consent Order with the following terms and conditions:

A. TriHaz agrees to pay to the Department a civil penalty in the amount of \$4,240 in settlement of the violation(s) alleged herein within forty five (45) days of the effective date of this Consent Order. Failure to pay the civil penalty within forty-five (45) days from the effective date may result in the Department's filing a civil action in the Circuit Court of Montgomery County to recover the civil penalty.

B. TriHaz agrees that all penalties due pursuant to this Consent Order shall be made payable to the Alabama Department of Environmental Management by certified or cashier's check or other payment methods acceptable to the Department and shall be remitted to:

Any payment submitted to the Department pursuant to this Consent Order shall reference TriHaz's name and address, and the ADEM Consent Order Number of this action.

C. TriHaz agrees to comply with all applicable terms, conditions, and limitations of the permit, the AIIWMMMA, Ala. Code §§ 22-30-1 to 22-30-24, as amended, and the regulations promulgated pursuant thereto immediately upon the effective date of this Order and continuing every day thereafter.

D. The Department and TriHaz ("Parties") agree that this Consent Order shall apply to and be binding upon both parties, and both parties shall direct their directors, officers, and employees implementing this Consent Order to comply with its provisions. Each signatory to this Consent Order certifies that he or she is fully authorized by the party he or she represents to enter into the terms and conditions of this Consent Order, to execute the Consent Order on behalf of the party represented, and to legally bind such party.

E. The Parties agree that, subject to the terms of these provisions and subject to provisions otherwise provided by statute, this Consent Order is intended to operate as a full resolution of the alleged violation(s) cited herein.

F. TriHaz agrees that it is not relieved from any liability if it fails to comply with any provision of this Consent Order.

G. For purposes of this Consent Order only, TriHaz agrees that the Department may properly bring an action to compel compliance with the terms and conditions contained herein in the Circuit Court of Montgomery County.

H. The Parties agree that the sole purpose of this Consent Order is to resolve and dispose of all allegations and contentions stated herein concerning the factual circumstances referenced herein. Should additional facts and circumstances be discovered in the future which would constitute possible violations not addressed in this Consent Order, then such future violations may be addressed in orders as may be issued by the Director, litigation initiated by the

Department, or such other enforcement actions as may be appropriate. TriHaz agrees not to object to such future orders, litigation, or enforcement actions based on the issuance of this Consent Order if future orders, litigation, or other enforcement actions address new matters not raised in this Consent Order.

I. The Parties agree that this Consent Order shall be considered final and effective immediately upon signature of all parties. This Consent Order shall not be appealable, and TriHaz does hereby waive any hearing on the terms and conditions of this Consent Order.

J. The Parties agree that this Consent Order shall not affect TriHaz's obligation to comply with any federal, State, or local laws or regulations.

K. The Parties agree that final approval and entry into this Consent Order are subject to the requirements that the Department give notice of proposed orders to the public, and that the public have at least thirty days within which to comment on the Order.

L. The Parties agree that, should any provision of this Consent Order be declared by a court of competent jurisdiction or the Environmental Management Commission to be inconsistent with federal or State law and therefore unenforceable, the remaining provisions hereof shall remain in full force and effect.


M. The Parties agree that any modifications of this Consent Order must be agreed to in writing signed by both parties.
